

Panelist 1: Felipe Bayon, Senior Vice President BP America and Head of Global Deepwater Response

Felipe graduated from Universidad de los Andes, Bogota, Colombia in 1989 with a degree in Mechanical Engineering.

Felipe has over 24 years of experience in the Oil and Gas industry in business leadership and technical managerial roles within Exploration and Production (E&P), the last 20 of them with BP.

Felipe is a member of the Leadership Team of BP America and has a direct reporting line to the Chairman and President of BP America. From 2005 to 2010,

Felipe was the BP Regional President Southern Cone and Chief Executive Officer (CEO) of Pan American Energy (PAE, a Joint Venture 60% owned by BP). During this period, Felipe led PAE's oil and gas exploration and production operations in Argentina, Bolivia, Uruguay and Chile.

During his BP career, Felipe served as Head of the BP Exploration and Production Executive Office and was the Chief of Staff to the BP Exploration and Production Chief Executive Officer. His career with BP started in Colombia where he held several positions until he was promoted to BP Colombia Operations Vice President. Felipe started his career in the industry with Shell in Colombia as a Project Engineer. Felipe, his wife Maria, and their two children Jose Alejandro and Veronica live in Houston

He joined the TLC Seismic Processing Center in 1982 and worked for Exxon Production Research Company and Exxon Company USA from 1985 to 1998. In 1998, he joined CGG in its Houston office and has since continued to work closely in seismic imaging research and applications.



Panelist 4: Albert Ku, P.E., Founder and Managing Director at Energo

Dr. Ku was born and raised in Taipei, Taiwan. He received his bachelor and master degree, both in Civil Engineering, from Cheng Kung University (Tainan, Taiwan) and Chiao Tung University (Hsinchu, Taiwan), respectively. Before he came to the States for further graduate study, he spent two years at Taiwan University (Taipei, Taiwan) working as a research assistant in the field of Earthquake Engineering. Later he received his PhD in Civil Engineering from Rice University in Houston, Texas. After graduating from Rice he worked at McDermott Engineering, EQE (a

structural consultant company) and American Bureau of Shipping (ABS) between 1997 and 2004. In 2004 he founded Energo Engineering with 3 other partners with the focus on advanced structural analysis and structural integrity management. Energo was acquired by Kellogg Brown & Root (KBR) in 2010, and Dr. Ku is currently the Managing Director of Energo. Dr. Ku is the author or coauthor of 25 journal and conference papers. He received 2nd prize in paper competition as a graduate student in the 1996 Southwest Mechanics Conference, as well as Best Paper Prize in 2013 during the Deep Offshore Technology Conference. Dr. Ku is currently the chairman of API Task Group 19 which focuses on next generation of fixed offshore structural design.



Panelist 5: Guan Qin, Associate Professor of Petroleum Engineering and Society of Petroleum Engineers – Gulf Coast Section Endowed Distinguish Chair at University of Houston

Guan Qin currently is Associate Professor of Petroleum Engineering at Department of Chemical & Biomolecular Engineering and holds Society of Petroleum Engineers – Gulf Coast Section Endowed Distinguish Chair at University of Houston. In that capacity, he has been building a research program with a focus on mathematical modeling and numerical simulation of unconventional hydrocarbon resource development Prior to his current position, Guan Qin was Associate Professor of Petroleum Engineering at University of Wyoming, Assistant Vice President for Research, Office of Vice President for Research (VPR), and Associate Director for Institute for Scientific Computation (ISC) at Texas A&M University. In his capacity as an Assistant Vice President for Research and director for research at ISC, he has focused on developing global research collaboration and industry outreach, which creates synergy for interdisciplinary research activities and for attracting global research funds. Prior to his academic career, Guan has more than 12 years progressive industry working experience in major oil companies that include Exxon Mobil Upstream Research Company, Mobil Technology Company and, China National Petroleum Corporation.

Guan Qin received B.S. degree in Engineering Mechanics at Tsinghua University, China in 1984, M.E. degree in petroleum engineering at China Research Institute of Petroleum Exploration & Development (RIPED), China National Petroleum Corporation (CNPC) in 1987, and received Ph.D. degree in petroleum engineering at University of Wyoming in 1995.



Panelist 6: Cheryl Byington, HR Director for Westlake Property Management and Upstream Finance Development Programs at BP

During her tenure at BP (previous with Amoco), she has held various positions, integrating HR and Finance.
