

Appendix: Biography of Panelists



Panelist 1: Jim Wu, President of 1898 Club LLC and President of Houston International Trade Development Council

Ralph Eguren is currently Segment Engineering Technical Authority (SETA) in Process Engineering for BP America. His previous roles have included Process Engineering Deputy EA and Technical Authority for BP's North America Gas (NAG) US operations, process engineer for various North America gas plants, lead startup and commissioning engineer for the Colombia South Amercia gas plant for Amoco Production, and Research Engineer in Amoco Research Center in Tulsa OK. His tenure with BP and Amoco has spanned 40 years of service.

Ralph presently serves on a number of industry committees such as Laurance Reid Gas Conditioning and a technical rep for GPA Midstream. He has published over 25 articles in various technical journals all relating to natural gas processing. Ralph is also a member of AIChE and SPE. Ralph holds a BS in Chemistry, a BS and MS in Chemical Engineering from the University of Tulsa (OK). He is member of BPs' Wisdom and Experience BRG.



Panelist 3: Leonard Chaikind, CEO at ITCC and Chairman at Better World Foundation

Leonard Chaikind is the Chairman & CEO of Institutional Investors Consulting Company or IICC, located in Houston, Texas. Mr. Chaikind has served in this capacity since he founded IICC in the early 1990's. In addition to several projects in various countries, IICC is in the process to start 4 Private Equity Funds – each being from \$250 to \$500 million dollars – in the areas of real estate, entertainment / media, and energy.

Prior to founding IICC, Mr. Chaikind worked for Royal Dutch Shell and the Shell Oil Company for over 34 years in a wide variety of assignments. After serving in many senior roles, including the Finance Manager for both

Shell Chemical and Shell Oil Products, he moved to the Royal Dutch Shell headquarters in London in 1977.

He served as Regional Treasurer for all Royal Dutch Shell's operations in the Far East and Australasia. He was responsible for negotiating and financing well over \$40 billion dollars in both corporate and major project activities though out this region. In 1981, he returned to Houston to continue his career.

His final assignment for Shell was as the Administrator of the various \$12 plus billion dollars Shell Savings and Retirement Programs with responsibility for both the investment and administration of 4 major funds. He was one of the key founders of the Committee on Investment of Employee Benefit Assets (CIEBA), the largest ever Corporate Pension Fund Group in the World, and served as Vice Chairman of this group from its beginning until his retirement from Shell. He also served as an active member of both the NYSE Institutional Investors Advisory Committee and the Commodity Futures Trading Commission Advisory Board (the CFTC is to the futures and derivatives industry what the SEC is to securities industry).

Mr Chaikind has an MBA from Harvard Business School in 1958, BA Harvard University in Economics in 1953 and endless courses at places like NYU, CCNY, Columbia, The New School for Social Research, and the US Navy. Prior to all this, Mr. Chaikind was a graduate in 1949 of the Loomis Institute, which is in Windsor, CT




Panelist 4: Greg Withers, Engineering Director for Offshore Projects at BP
