

Appendix: Biography of Panelists



Panelist 1: Dr. Liang Jin, founder of BrightGold Consulting LLC & former production technologist at Shell

Dr. Liang Jin has over 30 years' experience in petroleum industry. He is the owner of BrightGold Consulting LLC. in Houston. Before retiring from Shell, Liang had served as senior staff production technologist, an SME (subject matter expert) in damage removal and stimulation on both conventional and unconventional reservoirs. His contributions to Shell business includes leading acid stimulation campaigns in Southeast Asia assets; designing drilling and completion fluids in Shell China Changbei project that is considered PetroChina's international cooperation role model in China; New Business Development on multiple projects around the globe; playing leading role in developing tight gas and shale gas projects in Sichuan, China; leading an integrated work team in technical support of appraising a

liquid rich shale project in Argentina; leading the deployment of diverting technology in unconventional resources in North America. His last role was to promote integrated approach to optimize completion and production to maximize value over the life of the assets.

Before joining Shell, Liang had worked with other North American operators in tight gas and conventional assets. He had contributed to the first massive scale hydraulic fracturing in Sichuan in late 90s. He also spent 5 years in StimLab as engineering manager conducting hydraulic fracture related research projects and the building of proppant database.

Dr. Jin has wide connections with the industry and is an active SPE member with 25+ technical publications some of which are published in renowned journals.

His academic degrees include B.S. from Southwestern Petroleum University (China), M.S. from Research Institute of PetroChina, and Ph.D. from The University of Texas at Austin all in petroleum engineering.

Mr. Meng worked for Procter and Gamble (P&G), the largest consumable products company for 21 years. His final role with P&G was General Manager of Hong Kong & Taiwan Supply Chain. He was also the founder of the HKTW eCommerce supply chain for P&G.

Prior to that, Mr. Meng was Plant Manager for a P&G plant in Cape Girardeau, Missouri, which is one of the largest manufacturing sites of P&G and produces 40% Pampers/ Luvs for the North America market. He became the first Asian to assume the plant manager role for P&G in North America.

Before the assignment in Missouri, Mr. Meng was General Manager of P&G Greater China Baby Care Supply Chain and Start-up Manager for P&G's newest plant in China. In this capacity, he was leading a multi-tasked team responsible for supply network design, customer service, total delivery cost and new products launch for a fast growing business. He was also setting up benchmarks for the diaper industry to build and start up a high standard plant within 12 months.

Mr. Meng holds Master and Bachelor Degrees in Thermal Power Engineering from Harbin Institute of Technology, ranked No. 6 best engineering school by US news in 2019.
